From the Executive Director's Desk

Dear Friends of SASSMM:

As you will note within this newsletter, SASSMM continues to be creative in reaching our communities. Our project reports bring you up to date on all that is happening here, and highlights some of the amazing work of our staff, volunteers and Board of Directors.

Our 2009 agency statistics reflect a year filled with advocacy and support:

- 1,236 contacts were made to our support line
- Those 1,236 contacts represented 233 survivors
- Of the 233 survivors, 37 are males
- 84 of the assaults occurred in this calendar year
- 145 of the assaults occurred at age 18 or younger
- Of the 233 survivors, 75 filed reports with law enforcement
- And 48 of the 233 received medical services

SASSMM public education programs and participant attendance increased in 2009.

- Non-school based educational programs reached 5,486 individuals
- School-based educational programs reached 5,721 participants

The statistics indicate the ongoing need for our services and represent the essential community partnerships that contribute to SASSMM's successes. It is easy to disregard numbers and

explain away statistics. For those of us at SASSMM, we know all too well that the statistics represent real people who could be you or me.

April is Sexual Assault Awareness Month. For those impacted by sexual violence and for those of us at SASSMM, Sexual Assault Awareness happens daily throughout the year. We are appreciative of your energy, commitment and activism as we work together to confront sexual violence. Please continue to speak up; together we can create healthier, safer communities.

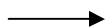

Education Corner

In the calendar year 2009, SASSMM educators provided peer- and sexual violence awareness and prevention programs to 5,350 students, faculty and staff in many of the elementary, middle and high schools in the Midcoast area.

In an ongoing effort to assess the efficacy of our school based educational programs, as well as to report program outcomes for federal, state and community funding sources, SASSMM asks each participant to complete an evaluation form at the conclusion of each presentation. 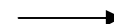

Sexual Assault Response Team Update

Hello to Midcoast Maine from a recently hired SASSMM staff member! I have been traveling throughout the region familiarizing and introducing myself to the Sexual Assault Response Team since I began in October 2009, and would like to give a small history of myself for those whom I have not yet met. I am a Maine native, a graduate of the College of the Atlantic, and my list of volunteer projects is nearly more extensive than my job history...including researching human trafficking in India, working



with a women's group against domestic violence in Belize, and volunteering on a sexual assault support line out of Ellsworth, Maine. By following an interest and instinct I sought out these experiences and they fortified a genuine calling in me. I feel incredibly fortunate to work alongside so many upstanding individuals with similar goals and ideals and want to thank all who are part of the Midcoast SART sincerely for your invaluable work, your dedication to ending sexual violence, and your warm welcome.

In December I had the benefit of arranging an annual Law Enforcement Workgroup—a unique opportunity for members of the Midcoast SART to network, discuss coordinating services, and learn about a sexual assault related topic. SASSMM arranges quarterly meetings for law enforcement and advocates; however, the annual meeting is held for all the members of the SART—including sexual assault forensic examiners/nurses, victim witness advocates, and representatives from other legal and social service agencies. The next quarterly meeting will be held in April, and Laura Brookham, SASSMM SART Advocate from 2001 – 2005 and fourth year doctoral candidate in the Clinical Psychology Program at Argosy University in Phoenix, Arizona, will be giving a presentation on *Forensic Psychology and Risk Assessment*.

April Workshop

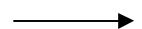

The Maine Campus Clothesline Project

There has been a lot of media attention recently about sexual assault on college campuses in this country. Research funded by the U.S. Department of Justice estimates that 1 in 5 college women will experience sexual assault during her college years. The vast majority of these students will know the



perpetrator - often well. The Center for Public Integrity has been studying sexual assault on campus and the responses of schools nationwide.

April is Sexual Assault Awareness Month. In recognition of this year's national campaign from the National Sexual Violence Resource Center, "Prevent Sexual Assault on our Campuses," the Maine Coalition Against Sexual Assault (MeCASA) has organized across campuses statewide to create the Maine Campus Clothesline Project. Students at campuses across Maine are decorating T-shirts to show the impact of sexual violence on their lives and on their campuses. These T-shirts will be displayed April 2nd at 11:30 am at the Hall of Flags in Augusta in an event that acknowledges sexual violence on campus. SASSMM is working with Bowdoin College in Brunswick. Students on campus will be participating in this year's event by making T-shirts on campus in March. Speaking out about sexual violence and recognizing its prevalence can help survivors and concerned others break their silence and be a part of the healing process.

Support Groups: A Piece of the Healing Process.

Survivors of sexual violence are often left with deep feelings of shame, guilt and embarrassment. Many feel they have no one to turn to for support and assistance.

SASSMM provides a casual and non-judgmental environment for individuals to connect with others who have been through similar life events. Participants share personal experiences, discuss information and exchange resources. Groups focus on healing and moving forward. A variety of survivor-centered groups are offered. 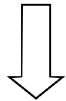

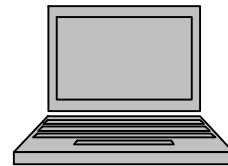
